**Secure Vendor Logistics -**

- Q1. What is the typical load size?  
**A1.** Anywhere from 15-100 pieces of equipment, or approximately 300 – 900 lbs.
- Q2. What are the typical assets and quantities being picked up to analyze the program?  
**A2.** PCs, laptops, printers, monitors, keyboards, mice, and miscellaneous small electronic equipment including recording equipment and calculators. Quantities may range from 15-100 pieces.
- Q3. Where in the building is equipment stored in relationship to the exit door/ dock?  
**A3.** From the loading dock, up the freight elevator to the 2<sup>nd</sup> floor, and approximately 250 feet down the hallway.
- Q4. Does the buildings have a loading dock?  
**A4.** Yes.
- Q5. Is it truck level?  
**A5.** Yes.
- Q6. Does a 5-ton truck fit? Or are there height/size restrictions?  
**A6.** Yes. There is a height restriction of approximately 15’.
