JUAN REYNOSO APPOINTED TO COUNTY BOARD OF PAROLE COMMISSIONERS

Ventura Superior Court Presiding Judge Bruce A. Young has appointed Juan Reynoso to serve as a member of the County Board of Parole Commissioners. His term began on August 15, 2021, and is for one year. The term may be extended for two additional one-year terms, not to exceed three consecutive years.

The County Board of Parole Commissioners is comprised of the Sheriff and the Probation Officer, or their designees, and a third member who is not a public officer, selected by the Superior Court Presiding Judge.

The Board establishes written rules and regulations for the granting of supervised parole to an inmate imprisoned within a county or city jail, or related facility. The rules and regulations, and the rationale behind them, are provided to each Ventura County Superior Court judge and persons in charge of the county's correctional facilities.

Upon an inmate's application for parole, the Board seeks input from the sentencing judge, to which it must give careful consideration before making its final determination. The Board may release a prisoner on parole for a term not to exceed three years.

Mr. Reynoso has a total of 34 years of law enforcement experience. He has worked for the Santa Barbara Police Department, Ventura Police Department, and Ventura County District Attorney's Office in a variety of assignments, including officer, supervisor and manager.

Police department assignments included Detective, Field Training Officer, Special Weapons and Tactics-Crisis Negotiator, 9-1-1 Communications Supervisor, and Sergeant in charge of the Professional Standards Unit (PSU). In PSU, he conducted all aspects of internal affairs investigations as well as POST approved backgrounds. He was later promoted to the rank of Commander, where he was a Watch Commander and oversaw the 9-1-1 Communications Center.

Initial assignments at the Ventura County District Attorney's Office included the Government Fraud Unit and Real Estate Fraud Unit. He was later promoted to Commander and was assigned to oversee the Major Fraud Unit, Child Abduction and Recovery Unit, and Special Response Team. He then transferred to the Administrative Unit where he oversaw and conducted all aspects of special investigations, internal affair investigations, and background investigations for every paid and volunteer position at the Ventura County District Attorney's Office, including attorneys, investigators, clerical staff and victim advocates.

Following his retirement from the district attorney's office in March of 2020, he started his own private investigations business, primarily conducting background investigations and workplace investigations for government agencies.

Mr. Reynoso holds a Bachelor's degree from the University of California, Santa Barbara, and a Master's degree in Business and Organizational Management from University of La Verne. He is also a graduate of the California Commission of Peace Officer Standard and Training Supervisor Leadership Institute.
